

## MISSION/PURPOSE

THE ASPHALT CONTRACTORS ASSOCIATION OF FLORIDA, INC. (ACAF, INC.), WAS FOUNDED IN 1957 AS A 501(C) 6 ORGANIZATION REPRESENTING THE ASPHALT INDUSTRY IN FLORIDA. THE FOUNDING PRINCIPLES WERE TO IMPROVE THE QUALITY OF ASPHALT AND TO EXPAND ITS USE. ASPHALT IS THE PAVEMENT OF CHOICE IN FLORIDA AND IS UNIQUELY SUITED TO PROVIDING A SAFE, SMOOTH, DURABLE, AND ECONOMICAL DRIVING SURFACE FOR TAXPAYERS AND OWNERS OF THESE FACILITIES. ASPHALT IS USED ON 98-99% OF THE PAVED SURFACES IN FLORIDA.

ACAF'S MEMBERSHIP CONSISTS OF ASPHALT PRODUCERS AND ASSOCIATE MEMBERS AND AFFILIATE MEMBERS – ALL WORKING IN OR SUPPLYING MATERIALS AND/OR EQUIPMENT FOR USE IN THE ASPHALT INDUSTRY. THE ASSOCIATION'S OFFICES, LOCATED IN TALLAHASSEE, FLORIDA, ENABLE IT TO WORK CLOSELY WITH THE STATE DEPARTMENT OF TRANSPORTATION AND THE FEDERAL HIGHWAY ADMINISTRATION AS WELL AS OTHER INDUSTRY ASSOCIATIONS.

ACAF IS THE VOICE OF THE ASPHALT INDUSTRY BEFORE THE FLORIDA LEGISLATURE, CONGRESS, AND STATE GOVERNMENT WHERE IT ADVOCATES THE EFFICIENT SPENDING OF TRANSPORTATION REVENUE AND QUALITY CONSTRUCTION THAT PROMOTES MOTORIST SAFETY, RELIEVES CONGESTION, AND IMPROVES TRAFFIC FLOW.

THE ASSOCIATION PROVIDES ITS MEMBERS WITH NEW AND INNOVATIVE INFORMATION RELATING TO ASPHALT AND CONSTRUCTION SPECIFICATIONS. ACAF WORKS CLOSELY WITH FDOT TO FORMULATE SPECIFICATIONS FOR ASPHALT AND CONSTRUCTION THAT IMPROVE THE QUALITY OF THE HMA AND ARE REASONABLE AND CONSTRUCTIBLE. ALONG WITH

TECHNICAL ASSISTANCE, STAFF PROVIDES QUALITY CONSTRUCTION TRAINING, TECHNICAL SUPPORT, AND IN HOUSE TRAINING UPON REQUEST. ACAF IS AN ACTIVE PARTICIPANT IN THE NATIONAL COOPERATIVE HIGHWAY RESEARCH PROGRAM (NCHRP) PROJECTS AND WORKS CLOSELY WITH THE NATIONAL CENTER OF ASPHALT TECHNOLOGY (NCAT).

## DUES STRUCTURE

- **REGULAR MEMBERS** (5 CENTS PER TON FOR FIRST 400,000 TONS PRODUCED DURING SEPTEMBER 1 TO AUGUST 31. MINIMUM DUES OF \$3,000 PER YEAR. MAXIMUM DUES OF \$20,000. DUES ARE BILLED MONTHLY.
- **ASSOCIATE MEMBERS:**
  - \$7,500 PER YEAR FOR ASPHALT/BITUMINOUS MATERIAL SUPPLIERS, AND AGGREGATE PRODUCERS/SUPPLIERS CATEGORIES;
  - \$2,500 PER YEAR FOR ASPHALT CONTRACTOR (NON-PRODUCERS), MILLING CONTRACTORS, AND SPECIAL MATERIALS.
  - PAID QUARTERLY OR ANNUALLY.
- **AFFILIATE MEMBERS:** \$1,500 PER YEAR FOR ALL CATEGORIES, PAID QUARTERLY OR ANNUALLY.
- *CONTRIBUTIONS AND MEMBERSHIP DUES MAY NOT BE DEDUCTED AS CHARITABLE CONTRIBUTIONS; HOWEVER, SUCH DUES MAY BE DEDUCTED AS ORDINARY AND NECESSARY BUSINESS EXPENSES.*
